PARISH FINANCES 2017

We were recently advised by the diocese (our parish being part of the A&B Registered Charity 252878) that the Diocesan Accounts for 2017 have now been approved and that we can publish the Guildford figures.

This sheet gives a summary of the Accounts which will also be published on the Parish Website (CPG.Church). As you will see the figures for 2016 have been included for ease of comparison alongside some footnotes of explanation.

What the figures reveal is an increasing gap between the income and expenditure. The Finance Committee members, with Geoff Bignell (Chair) and the clergy have been working closely to reduce expenditure to a minimum in 2018 while we make plans to address the situation.

In the autumn there will be more information about the proposals for the years ahead: not just for the finances but for the important Pastoral work they make possible.

For now the most important thing is to say Thank you to all those who give regularly to the Parish and its life – only with your support is a huge amount of the good and faithful possible.

Together we give thanks to God. It will be important to keep the focus on the Lord and the priorities of Prayer, Formation & Mission.
